In continuation with this office letter dt.13-09-2023 and Rly Bd's letter dt.02-01-2024 cited above, it is hereby informed that consequent upon migration ARPAN data base to IPAS followed by development of the ARPAN modules in IPAS, the ARPAN Application will not be accessible to the existing ARPAN Users anymore, for the following Modules:

- (i) Debit Reconciliation Module
- (ii) Pre-2016 Revision Module (including re-revision of ARPAN PPOs)
- (iii) Pre-2016 PPO Re-Grant Module (Fam. Pen to dependent son/daughter)

Since the above Modules have been developed and deployed Live in IPAS, the activities relating to Reconciliation, Revision and Re-Grant of pre-2016 PPOs, will henceforth be carried out by railways in IPAS (under newly created ARPAN menu in IPAS):

In addition, ARPAN-PPO download facility for railway pensioners has also been made available in public domain at https://aims.indianrailways.gov.in

In view of the above, the ARPAN Users may kindly be instructed to switch over to IPAS with immediate effect. The creation of Users in IPAS and their Access to the above IPAS-Modules, may be obtained through local IT Centre/DBA.

As you are aware, the activity of development of utility for reconciliation of e-pension debit scrolls under IPAS and its integration with Bank's server was under way at CRIS. Consequent upon readiness of this module, it has now been decided to carry out the pension reconciliation exercise in IPAS. This module (named as ARPAN module under IPAS) shall also facilitate creation of Pension Revision functionality for employees who retired before the implementation of IPAS and whose pension are yet to be revised.

It is therefore, advised that necessary directives may be issued to all concerned in this regard. ARPAN team of Western Railway may be approached for any support required to Railways during the migration process.

आपका ध्यान (2) पूर्वोक्त के तहत उद्धृत बोर्ड के पत्र की ओर आकृष्ट किया जाता है जिसमें आईपीएएस (अनुलग्नक-क) में अर्पण (एआरपीएएन) मॉड्यूल के तहत आईपीएएस की शुरूआत/परिचालन से पूर्व सेवानिवृत्त कर्मचारियों के पेंशन के समाधान और पेंशन में संशोधन करने का अनुदेश दिया गया था। अब अर्पण डेटाबेस को आईपीएएस में परिवर्तित कर दिया गया है और डेबिट समाधान के लिए मॉड्यूल को आईपीएएस में परिवर्तित कर दिया गया है, 2016 रिवीजन मॉड्यूल (अर्पण पीपीओ के पुन: संशोधन सहित) और प्री-2016 पीपीओ री-ग्रांट मॉड्यूल (आश्रित पुत्र/पुत्री को पारिवारिक पेंशन) की आईपीएएस में अर्पण मॉड्यूल के अंतर्गत विकसित किया गया है, अतः पश्चिम रेल ने सूचित किया है कि मौजूदा अर्पण उपयोगकर्ताओं के लिए अर्पण एप्लिकेशन इन कार्यो (अनुलग्नक-ख) को करने हेतु सुलभ नहीं होगा।
